



Introduction

A scheduled audit of the Federal & State Tax Withholding process for January 1, 2019 to December 31, 2019 has been completed by Internal Audit. The audit was conducted in conformance with the *International Standards of the Professional Practice of Internal Auditing*, upon which the Office of the Arkansas Lottery (OAL) Internal Audit policies and procedures are based.

Background

On a daily basis, OAL retailers sell lottery products to customers throughout the state. In connection with these sales, retailers are eligible to earn the following types of commissions per OAL Retailer Rules:

- Base Instant and Online Games Commission – 5% of the dollar value of tickets sold;
- Cashing Commission – 1% of the prize dollar value of winning tickets redeemed at retail locations up to the \$500 cashing limit per winning ticket for retailers;
- Selling Commission – 1% of the prize value for winning tickets sold by a retail location and subsequently validated and paid to the winner by the OAL Claim Center for prizes of \$10,000 or more per ticket; per ticket payout of a selling commission to a retailer is capped at \$50,000.

Payment of these commissions to retailers may trigger the need to report annual earnings by retailers to the Internal Revenue Service (IRS) based on a retailer's type of legal organization and earnings level during a calendar year. These same triggers would result in issuance of Form 1099-MISC to retailers outlining commissions earned during the year that were reported to the appropriate taxing authorities.

Under its contract with Intralot, Inc. (Intralot), the OAL is provided with a system that is used to capture retailer transactions, validate and pay player claims, and calculate the amount of commissions due to each retailer. Also under the contract with Intralot, annual tax report processing and printing of Form 1099-MISC for distribution to retailers must be provided to the OAL. The OAL Treasurer works with Intralot to coordinate the generation of tax reports and forms and ensures the completeness and accuracy of the information reported to taxing authorities and provided to retailers for their own tax return preparation.

Also on a daily basis, OAL players present tickets for validation and claim prizes at the OAL's Claim center in downtown Little Rock. Prizes that exceed the retailer cashing limit of \$500 must be processed by the

Claim Center, either via mail or in person, and prizes greater than or equal to \$1 million must be claimed in person.

Per IRS regulations, winnings of \$600 or more must be reported and Form W-2G issued to the claimant. IRS regulations also require withholding of federal income tax of at least 25% from claims of more than \$5,000. These same thresholds apply to state taxes, with a 7% withholding rate required by Arkansas Code Annotated (ACA) § 26-51-2304 (a) for single winning ticket claims of more than \$5,000.

IRS regulations require remittance of federal income tax withholdings on either a monthly or semi-weekly basis, depending on the total withholding liability incurred by an entity during a specified lookback period unless a single day's withholding liability is \$100,000 or more, in which case taxes withheld must be remitted no later than the following business day. ACA § 26-51-2305 (d) requires state income tax withheld from player winnings to be remitted on or before the fifteenth day of the month following the month in which the tax was withheld. In order to comply with and avoid the potential for unintentional violation of these requirements, the OAL accounting function remits federal taxes withheld on a daily basis and state taxes withheld weekly. Both remittances are accomplished electronically through the Electronic Federal Taxpayer System (EFTPS) and Arkansas Taxpayer Access Point (ATAP), which initiate ACH transactions in the OAL's operating bank account. On an annual basis, the accounting function completes the required reporting to the IRS for taxes withheld during the year (Form 945 and 945-A) and Arkansas Withholding Tax Return via ATAP.

Purpose, Objectives, and Scope

The overall purpose, objectives, and scope of the audit were as follows:

Purpose

The purpose of this audit was to ensure adequate controls and procedures are in place to assure that the OAL remits and reports tax withholdings and amounts paid to its retailers in a timely, complete, and accurate fashion, in accordance with the appropriate taxing authority's regulations.

Objectives

- Ensure that OAL withholds the appropriate tax withholdings from player's winnings and remit these withholdings in a timely standard to the appropriate tax authorities.
- Ensure that OAL withholds the appropriate tax withholdings from the retailer's commissions and remits these withholdings in a timely standard to the appropriate tax authorities.
- Ensure policies and procedures are in place to identify and correct TIN mismatches from retailers and lottery player winners. If mismatches occur, does the OAL resolve tax penalties assessed by the IRS or state taxing authorities and correct the issues in a timely standard.

Scope

The procedures performed included inspection and review of Back Office System (BOS) reports, electronic funds tax deposit confirmations, bank statements, and other system-generated reports and documents. Transactions and documentation selected for testing included items generated throughout and prepared for calendar year 2019.

Observation

IA had no observations or recommendations to report.
