**NARRATIVE**

ON 06/18/20 AT APPROXIMATELY 1135HRS, MR. JESSE SHELTON CALLED THE NORTHWEST SUBSTATION TO REPORT THAT ON 06/13/20 THE ABORTION DOCTOR AT 4 OFFICER PARK DRIVE ATTEMPTED TO RUN HIM OVER. MR. SHELTON CLAIMS HE AND OTHERS WERE STANDING ON THE SIDEWALK NEAR 4 OFFICER PARK DRIVE WHEN DR. NATALIE TVENTEN ATTEMPTED TO RUN HIM OVER WITH HER VEHICLE AND FELL TO A NEARBY BUSHES. MR. SHELTON SAID HE AND OTHERS WERE IN THE AREA TO COUNSEL WOMEN FOR ALTERNATIVES. I ASKED MR. SHELTON WHY HE DID NOT CALL THE POLICE WHEN THE INCIDENT OCCURRED. MR. SHELTON CLAIMS THAT HE HAD CALLED NUMEROUS TIMES AND LEFT MESSAGES FOR A CALL BACK. MR. SHELTON CLAIMS MS. TVEDTEN HAD ATTEMPTED TO RUN OVER OTHERS IN THE PAST ON 05/19/20 AND 05/29/2020. I INFORMED MR. SHELTON AN INFORMATIONAL REPORT WOULD BE FILED.
