Unopposed Motion to Hold Appeal in Abeyance

Defendants-Appellants respectfully submit this unopposed motion to hold this appeal in abeyance pending a decision in *Dobbs v. Jackson Women's Health Organization*, No. 19-1392 (U.S.).

This appeal is from the district court's injunction of Arkansas Act 309 of 2021. That law prohibits elective pre-viability abortions, with certain exceptions. Ark. Code Ann. 5-61-401 et seq. Last term, the Supreme Court granted certiorari on the question "[w]hether all pre-viability prohibitions on elective abortions are

unconstitutional." *Dobbs*, No. 19-1392 (U.S. May 17, 2021). Merits briefing in that appeal is already well underway.

In light of *Dobbs*, this Court has already granted a motion to hold in abeyance an appeal concerning related pre-viability abortion prohibitions. Order, *Hop-kins v. Jegley*, No. 21-1068 (8th Cir. May 26, 2021). Similarly, here, guidance from *Dobbs* will materially benefit both parties' briefing and argument as well as this Court's consideration of the issues presented in this appeal. Therefore, in the interest of judicial economy and conserving the parties' resources, Defendants-Appellants respectfully request that all proceedings in this case, including briefing and argument, be held in abeyance pending the Supreme Court's decision in *Dobbs*.

Defendants-Appellants have conferred with Plaintiffs-Appellees, who stated no objection to this motion and affirmatively stated that they take no position.
