

### **NARRATIVE**

OFFICERS RESPONDED TO THE LISTED ADDRESS IN REFERENCE TO A DELAYED BATTERY REPORT. SHEWMAKE ADVISED TVEDTEN DROVE TOWARDS HER, HOPPED A CURVE AND ATTEMPTED TO HIT HER WITH VEHICLE 1. SHEWMAKE WAS NOT STRUCK BY THE VEHICLE. OFFICERS REVIEWED VIDEO FOOTAGE OF THE INCIDENT. SHEWMAKE WAS OBSERVED WALKING ACROSS THE DRIVE WAY OF 4 OFFICE PARK. VEHICLE 1 WAS OBSERVED TURNING INTO THE DRIVEWAY IMMEDIATELY AFTER SHEWMAKE STEPPED ONTO THE CURB. TVEDTEN STATED, "YOU BETTER WATCH OUT OR YOU MAY GET RAN OVER." OFFICERS COULDN'T DETERMINE HOW CLOSE THE VEHICLE WAS TO SHEWMAKE OR IF THE DRIVERS ACTIONS WERE INTENTIONAL. DETECTIVE DILLARD WAS NOTIFIED OF THE INCIDENT. MVR AND BWC IN USE.
