SUMMARY

On **July 13, 2021**, at *approximately 1522 hours*, Officer Alyssa Lee was dispatched to a Battery report at 10825 Hermitage Road (Butcher Shop Steakhouse). Upon Officer Lee's arrival, she activated her Mobile Video Recorder (MVR) and Body Worn Camera (BWC). Officer Lee's BWC showed the following:

Officer Lee made contact with Denise Shewmake (W/F, 02/05/1960). Ms. Shewmake advised earlier in the day she was at 4 Office Park Drive (Little Rock Family Planning Services), when the owner (who was later identified as Natalie Tvedten, W/F, 01/29/1964), tried to run her over. Ms. Shewmake stated there was another subject present during the incident (who was later identified as Kimberly Puska, W/F, 03/03/1962).

Ms. Shewmake advised Officer Lee that her and Ms. Puska were praying. Ms. Shewmake advised her back was to the road when Ms. Puska told her to watch out. Ms. Shewmake advised she turned around and saw Ms. Tvedten drive over the curb marking Ms. Shewmake jump into nearby landscape to avoid being hit. Ms. Shewmake advised she was holding materials in her hand that she dropped when she jumped out of the way. Ms. Shewmake advised Ms. Tvedten drove over the materials that Ms. Shewmake dropped. Ms. Shewmake advised the suspect drives close to her and others frequently, but this time she was much closer and almost hit her. Ms. Shewmake advised Ms. Tvedten has threatened to run people over in the past.

Officer Lee additionally made contact with Ms. Puska outside of Little Rock Family Planning Services. Ms. Puska advised she was with Ms. Shewmake and saw the suspect driving on the street towards them. Ms. Puska advised she saw the suspect angle towards them, so she backed out of the way and told Ms. Shewmake to back up. Ms. Shewmake advised they were almost hit.

Officer Lee responded to Little Rock Family Planning Services. Officer Lee made contact with an unidentified black male standing in front parking lot of the business, and asked for "Natalie". The unidentified black male stated he would go and get her. The unidentified black male stated returned to the front parking lot of the business with a white female, later identified as Ms. Tvedten. Officer Lee advised Ms. Tvedten that there were two (2) ladies who stated she tried to hit them. Ms. Tvedten stated they were standing in the driveway, she did not see them when she almost hit them. Ms. Tvedten stated if she was not standing in the driveway she would not have almost hit them. Ms. Tvedten stated subjects have been told on previous occasions not to stand in the driveway.

Officer Lee provided Ms. Tvedten and Ms. Shewmake the incident number for this case and left without taking further action.

This report was filed under Incident #2021-082658.

On **July 27, 2021**, Incident #2021-082658 was assigned to Detective Troy Dillard for investigation.

Detective Dillard received overt Little Rock Police Department City Camera (City Camera) video for July 13, 2021 from 0805 hours to 0900 hours. The City Camera is situated on a pole just north of the location, facing a southern direction and captures the driveway of 4 Office Park Drive (Little Rock Family Planning Service). The video frame captured the entirety of the drive way, as well as approximately a car length or two north of the driveway, and further south along Office Park Drive.

The City Camera footage showed the following:

The City Camera footage showed two (2) subjects, later identified as Ms. Shewmake and Ms. Puska, standing on the southern side of the driveway, close to the sidewalk. Based on the angle of the footage, both appear to be within a few feet in the driveway from the sidewalk. The City Camera footage showed a dark colored vehicle traveling southbound on Office Park Drive. The City Camera footage showed the dark colored vehicle drive close to the edge of the driveway and the sidewalk, to the point where the rear passenger tire rolled over the western curb line of Office Park Drive on the northern side of the driveway, near Ms. Shewmake and Ms. Puska. During this time, Ms. Shewmake and Ms. Puska can be seen moving to the side, further north. One of the persons who was closest, appeared to have her belongings previously in her hands, run over by the vehicle during the incident. Both appeared to be on the sidewalk when the actual incident occurred when the dark colored vehicle traveling southbound ran partially onto the curb and sidewalk. Based on the angle of the footage, the driver could not be seen. There did not appear to be anyone else present during the incident. The specific speed of the dark colored vehicle could not be determined.

At *approximately 1607 hours*, Detective Dillard conducted a recorded interview with Ms. Shewmake at the 12th Street Substation. Ms. Shewmake related events of the incident consistent with the video and her statement to Officer Lee. Ms. Shewmake additionally stated she recognized the driver as Natalie Tvedten, from seeing her numerous times. Ms. Shewmake stated Ms. Tvedten frequently does this and yells and curses at them that she will run them over if they are ever in her way. Ms. Shewmake added that she did not see anyone else in the suspect's vehicle other than Ms. Tvedten as the driver.

Detective Dillard showed Ms. Shewmake a still shot photograph from the overt City Camera footage of the two subjects. The still shot photograph did not show the suspect vehicle. Ms. Shewmake positively identified both herself and Ms. Puska as the two people in the photograph.

Ms. Shewmake provided photographs she took at the scene, after the incident. The photographs show measurements she and another subject took of the curb and driveways. The photographs were included in the Case File.

At *approximately 1624 hours*, Detective Dillard showed Ms. Shewmake a photographic line-up featuring the Arkansas Driver's License photograph of Natalie Tvedten (W/F, 01/29/1964), and five (5) similar subjects. Ms. Shewmake tentatively identified position #6 as a person whose facial features resembled Ms. Tvedten but her hair was a different color. Position #6 was the Arkansas Driver's License photograph of Ms. Tvedten.

Detective Dillard called Ms. Puska who stated she would come to the 12th Street Substation on July 28, 2021, at 1630 hours to provide a statement.

On **July 28, 2021**, at *approximately 1258 hours*, Detective Dillard called 501-786-8491. This number returned from the TLO database under Ms. Tvedten as a number associated with Ms. Tvedten. When Detective Dillard called the phone went to voice mail with a female's voice stating the voice mail belonged to "Natalie". Detective Dillard left a message announcing his name and occupation and requested a call back.

At *approximately 1305 hours*, Detective Dillard received a missed call and voice mail from Ms. Tvedten.

At *approximately 1307 hours*, Detective Dillard called Ms. Tvedten back and made contact with her. Detective Dillard informed Ms. Tvedten that he was conducting an investigation in reference to an incident that occurred at her clinic on Office Park Drive. Detective Dillard told Ms. Tvedten that Detective Dillard could not discuss the incident in detail over the phone, but there were allegations made against her and that Detective Dillard wanted to get a recorded statement from her about the allegations. Ms. Tvedten requested Detective Dillard come to her location at 4 Officer Park Drive to provide the statement due to her having done nothing wrong. Detective Dillard agreed and informed Ms. Tvedten that he could come to her location, but he could not conduct an interview with her with third party witnesses present and that the statement needed to

be in a controlled environment. Ms. Tvedten stated she could not guarantee there would not be other people coming in and out during the interview. Detective Dillard then told Ms. Tvedten that he would not be able to do a statement in those conditions and requested they meet at a different location. Ms. Tvedten stated she would just contact Detective Dillard at a later date if she changed her mind about providing a statement, but at the moment she did not want to provide a statement due to having other obligations and concerns involving ongoing protesting. Detective Dillard informed Ms. Tvedten he would continue the investigation and if she changed her mind to give him a call.

At *approximately 1624 hours*, Detective Dillard conducted a recorded interview with Ms. Puska at the 12th Street Substation. Ms. Puska provided a statement consistent with Ms. Shewmake's statement.

Detective Dillard showed Ms. Puska a still shot photograph from the overt City Camera footage of the two subjects. The still shot photograph did not show the suspect vehicle. Ms. Puska positively identified both herself and Ms. Shewmake as the two people in the photograph.

At *approximately 1636 hours*, Detective Dillard showed Ms. Puska a photographic line-up featuring the Arkansas Driver's License photograph of Natalie Tvedten (W/F, 01/29/1964), and five (5) similar subjects. Ms. Puska tentatively identified position #2 as Ms. Tvedten. Position #6 was the Arkansas Driver's License photograph of Ms. Tvedten.

On **July 31, 2021**, Ms. Shewmake provided a photograph of an outline of the area, and stated the photograph showed the area in which Ms. Shewmake and Ms. Puska were standing during the incident was part of an easement.

On **August 2, 2021**, Detective Dillard saved all Mobile Video Recorder (MVR) and Body Worn Camera (BWC), Detective Dillard could locate from Officer Lee's contact on the date of the incident. The videos are saved on the cloud server titled "Incident #2021-082658", and can be provided via a link once requested.

Detective Dillard requested and received the Little Rock Police Department Communications audio statements and CAD report for Incident #2021-082658. The audios are included in the Case File for review.

After reviewing the statements, evidence, and the file, Detective Dillard submitted the file for a File Review to the Pulaski County Prosecuting Attorney's Office.

On **July 27, 2021**, I was assigned this case as the primary Detective.

Detective Dillard received overt City Camera video for July 13, 2021 from 0805 hours to 0900 hours. The City Camera is situated on a poll just north of the location, facing a southern direction and captured the driveway of 4 Office Park Drive (Little Rock Family Planning Service). The video frame captured the entirety of the drive way, as well as approximately a car length or two north of the driveway, and further south along 4 Office Park Drive.

The City Camera footage showed two (2) subjects, later identified as Ms. Shewmake and Ms. Puska, standing on the southern side of the driveway, close to the sidewalk. Based on the angle of the footage, both appear to be within a few feet in the driveway from the sidewalk. The City Camera footage showed a dark colored vehicle traveling southbound on Office Park Drive. The City Camera footage showed the dark colored vehicle drive close to the edge of the driveway and the sidewalk, to the point where the rear passenger tire rolled over the curb of the sidewalk on the northern side, near Ms. Shewmake and Ms. Puska. During this time, Ms. Shewmake and Ms. Puska can be seen moving to the side, further north. One of the persons who was closest, appeared to have her belongings ran over that was previously in her hands. Both appeared to be on the sidewalk when the actual incident occurred and when the dark colored vehicle traveling southbound ran partially onto the curb and sidewalk. Based on the angle of the footage, the driver could not be seen.

At *approximately 1607 hours*, I conducted a recorded interview with the victim, Denise Shewmake (W/F, 02/05/1960), at the 12th Street Substation. Ms. Shewmake related events of the incident consistent with the video. Ms. Shewmake additionally stated she recognized the driver as Natalie Tvedten, from seeing her numerous times. Ms. Shewmake stated Ms. Tvedten frequently does this and yells and curses at them that she will run them over.

At *approximately 1624 hours*, I showed Ms. Shewmake a photographic line-up featuring the Arkansas Driver's License photograph of Natalie Tvedten (W/F, 01/29/1964), and five (5) similar subjects. Ms. Shewmake tentatively identified position #6 as a person whose facial features resembled Ms. Tvedten but her hair was a different color. Ms.

Shewmake stated she was unable to positively identify anyone. Position #6 was the Arkansas Driver's License photograph of Ms. Tvedten.

I called Kim Puska (W/F, 03/03/1962), who was present during the incident. Ms. Puska stated she would come to the 12th Street Substation on July 28, 2021, at 1630 hours to provide a statement.

On **July 28, 2021**, at *approximately 1258 hours*, I called 501-786-8491. This number returned from the TLO database under Ms. Tvedten as a number associated with Ms. Tvedten. When I called the phone went to voice mail with a female's voice stating the voice mail belonged to "Natalie". I left a message announcing my name and occupation and I requested a call back.

At *approximately 1305 hours*, I received a missed call and voice mail from Ms. Tvedten.

At *approximately 1307 hours*, I called Ms. Tvedten back and made contact with her. I informed Ms. Tvedten that I was conducting an investigation in reference to an incident that occurred at her clinic on Office Park Drive. I told Ms. Tvedten that I could not discuss the incident in detail over the phone, but there were allegations made against her that I wanted to get a recorded statement from her about. Ms. Tvedten requested I come to her location to provide the statement due to her doing nothing wrong. I informed Ms. Tvedten that I could come to her location, but I could not conduct an interview with her with third party witnesses present and that the statement needed to be in a controlled environment. Ms. Tvedten stated she could not guarantee there would not be other people coming in and out. I then told Ms. Tvedten that I would not be able to do a statement in those conditions and requested I meet her in a different location. Ms. Tvedten stated she would just contact me at a later date if she changed her mind, but at the moment she did not want to provide a statement due to having other obligations and concerns involving ongoing protesting at the clinic. I informed Ms. Tvedten I would continue the investigation and if she changed her mind to give me a call.

At *approximately 1624 hours*, I conducted a recorded interview with Ms. Puska at the 12th Street Substation. Ms. Puska provided a statement consistent with Ms. Shewmake's statement.

On **July 31, 2021**, Ms. Shewmake provided a photograph of an outline of the area, and stated the photograph showed the area in which Ms. Shewmake and Ms. Puska were standing during the incident was part of an easement.

On **August 2, 2021**, I saved all Mobile Video Recorder (MVR) and Body Worn Camera (BWC), I could locate from Officer Lee's contact on the date of the incident. The videos
